MESSAGE FROM THE DIRECTOR



Welcome to the Social Security Research Centre (SSRC) at the Faculty of Economics and Administration, University of Malaya. As an integral part of Malaysia's most innovative university, SSRC has a vision of becoming the leader for scientific teaching and research on social security and a point of reference for those seeking to engage in contemporary issues on social security.

Our mission is to contribute and strengthen body of knowledge and applied research in social protection for the well-being of all. We act as a node for transforming research findings into initiatives for policy improvements and serve as a bridge between the academics and the society through collaborative efforts locally and internationally.

Malaysia is currently experiencing steady increase in the proportion of older people relative to the total population as a result of declining fertility and increasing life expectancy. The number of Malaysians aged 60 years and above is projected to reach 6.3 million in 2040, which is about 20% of total population. Ageing can entail multiple losses, including loss of work and physical functioning, and lesser reliance on income from employment. For most people there are lingering concerns about having adequate financial resources after retirement to pull through old age.

As the country progresses and aspires to become a developed nation, we cannot afford to have any section of the society being marginalized. It is a major challenge to ensure that the rights to social security becomes a reality for everyone. Income security in old age entails a secure and affordable access to social services including health care and long-term care. Failure by the government to provide such protection may cause older persons and their families to slide back into poverty. Therefore a universal protection becomes imperative to allow people a life in dignity. Understanding the dynamics impacting people's retirement enables us to prepare and develop a strategy based on realistic expectations; whether it is to work longer, save more, or invest more astutely.

We have to be mindful that the current pension system may not be sustainable as increases in pension payouts caused by ageing population would eventually put a strain on government's fiscal position. In Malaysia, we have a rich variety of institutions outside the public sector such as the Pensions Trust Funds or Kumpulan Wang Persaraan (KWAP) and Social Security Organisation (SOCSO) and private pensions institutions performing social protection functions. Policy makers can make the best use of their potential without undermining the existing public pension systems which has become a foundation on which at least basic income security has been built. The existence of private pensions institutions should complement the government's efforts in adopting a sustainable pension system.

Last but not least, I am proud to say that SSRC builds on the strengths of distinguished academicians and researchers - local and international, dedicated faculty members and collaborative partners. Among them are some of the most renowned individuals in the field, and their expertise and experiences are in line with the centre's vision of the future. We are honored that the Employee Provident Fund (EPF) of Malaysia has graciously provided an endowment fund in support of our efforts. Since its establishment in March 2011 SSRC has initiated and carried out various research, teaching and dissemination of evidence-based knowledge in this area in order to enhance the public understanding of this critical topic to promote economic development and social cohesion in Malaysia.

ABOUT SSRC

The Social Security Research Centre (SSRC) was established in March 2011 at the Faculty of Economics and Administration (FEA), University of Malaya. The Centre operates as a university-level, multi-disciplinary research unit to initiate and carry out research, teaching and dissemination of evidence-based knowledge in the area of social security, including old age financial protection in order to enhance the understanding of this critical topic to promote economic development and social cohesion in Malaysia.

The interest in social security and old-age financial protection is ever growing in view of ageing population not only faced by industrialized countries but by developing world as well. Malaysia is also subjected to rising life expectancy and falling fertility rates, the perceived inadequacy of current social security provisions, coupled with the added fear that simply more expenditure may not be conducive to the development and growth objectives of the society. This calls for innovative policy solutions that may be inspired by international experience based on an empirical grounding in national data and analysis.

To support the research in social security in general and old-age financial protection in particular, the Employees Provident Fund (EPF) of Malaysia has graciously provided an endowment fund to create the nation's first endowed Chair in Old Age Financial Protection (OAFPC) at University of Malaya. OAFPC has the over-riding objectives to help formulate policies to promote better social security and improve old age financial protection, and to help formulate policies to promote economic growth in an ageing society for consideration by the Government of Malaysia.

Besides with EPF, SSRC has also formed partnerships and collaborative agreements with Social Security Organization (SOCSO), Malaysia. These institutions provide a steady stream of innovative projects and creative investigations on social security topics. From these partnerships, SSRC holds the responsibility as custodian of databases obtained from Department of Statistics Malaysia, SOCSO and EPF. As such, SSRC is responsible for maintaining the databases as well as administering any distribution of the data.

From its origin, SSRC has had a strong interdisciplinary emphasis. Scientists from a number of disciplines, both on campus and off, come together in SSRC to work on common research problems. It is the norm to find various combinations of scientists from diverse disciplines in business, sociology, social work, economics and political science joining together their expertise on a given research problem. The range of interdisciplinary involvement goes beyond social security.

Norma Mansor is the Director of SSRC, a position she holds since 2013. She is a professor at the Department of Administrative Studies and Politics, Faculty of Economics and Administration, University of Malaya where she served as the Dean from April 2004 to June 2009. She was appointed as Secretary of the National Economic Advisory Council in Prime Minister's Department from July 2009 to May 2011. She was a Ragnar Nurkse Visiting Professor at Talinn University of Technology, Estonia in 2015. Prior to these appointments, she has served as advisor and consultant to various government bodies and private organizations which include The National Institute Of Public Administration (INTAN), Sarawak Economic Development Corporation (SEDC), Federal Agricultural Marketing Authority (FAMA), The United Nations Development Programme (UNDP), World Bank, International Labor Organization (ILO), Organisation for Economic Co-operation and Development (OECD) and the European Union (EU).

She holds a Ph.D. and Masters in Public Administration from Liverpool University (UK) and a Bachelor of Economics degree (hons) from University of Malaya. Her research interest includes public policy, governance and social protection. She has written extensively in books and scholarly journals. She sits as Editor in Chief of Institutions and Economies Journal, Member of Editorial Advisory Board of Public Management and Money and guest editor to several academic journals.

Deputy Director Sharifah Muhairah Shahabudin, Ph.D.



Sharifah Muhairah Shahabudin is the Deputy Director at SSRC. She is a senior lecturer at the Department of Development Studies at the Faculty of Economics and Administration, University of Malaya. Prior to her tenure at SSRC, she was involved in United Nation Development Program (UNDP)'s "Entrepreneurial Skills: Empowering Women", a two-year project undertaken in partnership between UNDP-MECD-MCCM.

She is currently involved in projects on Social Protection in ASEAN and The Globalization of Chronic Poverty in the Southeast Asian Cities. She holds a B.A from University of Canterbury, New Zealand, Masters of Science from MARA University of Technology (UiTM) and a PhD from University of Malaya. Her research interests cover youth and gender development and social protection.

His other project is on Policies for Coping with Declining Fertility and Population Aging at University of Tokyo funded by the Japan Society for the Promotion of Science (JSPS). He has completed several other projects funded by the Japan Medical Association, Ministry of Education, Culture, Sports, Science and Technology, Government of Japan and International Development Research Centre.

He is a Member of the United Nations International Technical Advisory Board for the Republic of the Union of Myanmar. His research and consultancy revolves around demographic and social security, fertility, intergenerational transfers, population aging, and social protection, mainly in Asia. He has published several books and written extensively in academic journals.

Distinguished Research Fellow and former Chairholder

Robert Holzmann, Ph.D.



Robert Holzmann was OAFPC's Chairholder from 2012 to 2015. He is currently SSRC's Distinguished Research Fellow. Robert is a professor of economics in University of Vienna, Austria. He is also the director of RH Institute for Economic Policy Analyses, Vienna and serves as Senior Advisor (consultant) to the World Bank. He was previously professor of economics at Harvard University (US), Oxford University (UK) and University of Saarland, Germany. He joined the Institute for the Study of Labor (IZA), Germany as a Research Fellow in 2003 and created with Klaus Zimmermann the Program on "Employment and Development" for which he now serves as Chair of the Scientific Committee. He researches, teaches and consults internationally on pensions, financial literacy/capability, labor and migration issues.

He has served as advisor and director in various prominent organizations such as OECD and the International Monetory Fund (IMF), where he headed various departments which include Social Protection, Labor, Pensions and Financial Literacy. His research and operational involvement extends to all regions of the world. He has published more than thirty books and over 150 articles on social, fiscal and financial policy issues.

Former Chairholder Sarah Harper, Ph.D.



Sarah Harper was the first Chairholder of OAFPC at SSRC. She is Professor of Gerontology and Senior Research Fellow at Nuffield College, Oxford University. Sarah serves on the UK Prime Minister's Council for Science and Technology, and chairs the UK government's Foresight Review on Ageing Societies, and the European Ageing Index Panel for the UNECE Population Unit. She is also the Governor of the Pensions Policy Institute. Throughout her academic career. Sarah has combined academic research with external professional commitments. She has served as advisor on demographic and population and ageing issues among others, to the governments of Malaysia, Singapore and the European Commission, the Swedish Academy, the MacArthur Foundation, the Calouste Gulbenkian Foundation and HSBC plc.

She founded the Oxford Institute of Population Ageing funded by the US National Institutes of Health. Her current research is on demographic change which addresses the global and regional impact of falling fertility and increasing longevity with particular interest in Asia and Africa.

Shahril Ridza Ridzuan was appointed as Chief Executive Officer effective 16 April 2013. He was previously Deputy Chief Executive Officer (Investment) of the EPF since 1 December 2009. He holds a Master of Arts (First Class) from Cambridge and Bachelor of Civil Law (First Class) from Oxford University, and has been called to the Malaysian Bar and the Bar of England and Wales.

Prior to joining the EPF, he was the Managing Director of Malaysian Resources Corporation Berhad (MRCB), where he was responsible for developing KL Sentral into one of the main commercial centres in Malaysia. His success at MRCB saw him being named Property CEO of The Year by the (International Real Estate Federation) FIABCI Malaysia branch in 2009. He previously served Pengurusan Danaharta Nasional Berhad, and was involved in corporate recovery and credit restructuring following the Asian Financial Crisis of 1997. He presently serves as a Non-Executive Board Member of Media Prima Berhad, Malaysia Building Society Berhad, Pengurusan Danaharta Nasional Berhad and Malaysian Resources Corporation Berhad.

Director of Munich Center for Economic Ageing (MEA) at the Max Planck Institute for Social Law and Social Policy (MIPISOC)



Axel Borsch-Supan is Director of the Munich Center for the Economics of Aging (MEA) at the Max Planck Institute for Social Law and Social Policy in Munich, Germany since January 2011. He is Professor of Economics and Chair for the Economics of Aging at the Technical University of Munich. Additionally, he is Managing Director of SHARE (the Survey of Health, Ageing and Retirement in Europe).

He has served as a consultant to many governments, the OECD and the World Bank, among others. An important field of his empirical research focuses on sociopolitical issues that are associated with economic aspects of demographic change and the aging of the population.

Stuart Gietel-Basten is an Associate Professor in the Department of Social Policy and Intervention as well as a Research Fellow at Green Templeton College, University of Oxford, UK. He is currently chair of the Asian Population Association Scientific Committee, convener for fertility of the European Population Conference and editor of the series Studies in European Population published under the auspices of the European Association for Population Studies.

His research interests focus on the interaction between population dynamics and social policy in Asia. Along with Professor Francesco Billari, he co-founded and is the editor of openpop.org, one of the world's leading collaborative blogs on population issues.

This seminar suggests that the rates employed to demonstrate the present/future scale of old-age dependency are misleading and based upon a Eurocentric notion from a bygone area. Arguing that these measurements both omit changes in life expectancy and fundamentally misconceptualise 'old' and 'dependent', this seminar presents a new series of comparative measurements based upon a dynamic view of remaining life expectancy and a more accurate concept of what it means to be 'dependent'.



Scholarly Output by Year




COMMUNITY OUTREACH

Impact of Return-to-Work (RTW) Program on EPF Contributions and National Economy The objective of the study is to examine the impact of RTW program on the injured workers, employers, SOCSO, EPF and the national economy. This study was done in collaboration with SOCSO to enhance and promote its RTW program that will result in improved successful RTW strategies, lower public assistance costs for tax payers and lower personnel costs for employers.

Malaysian Ageing and Retirement Survey The purpose of this study is to conduct longitudinal survey among the elderly aged 50 or older throughout Malaysia. The survey replicates some questions from SHARE and (Japanese Study of Aging and Retirement) JSTAR with the objective to find out information on the elderly aged 50 or older relating to their economic, financial and sociological condition. By employing the same method and questionnaire as JSTAR, a comparative study with Japan could be done in the future.

Reference Budget for Malaysian Households: A Preliminary Study The purpose of this study is to propose a reference budget for households in Malaysia by exploring spending patterns of the households, their needs and costs according to different characteristics that reflect the circumstances of individual family units and the expenses required for a minimum standard of living. Findings from this research is intended to assist with regards to debt management among households, credit scores, poverty alleviation and purchasing power parity.



Malaysia National Transfer Accounts (NTA) Study The objective of the project is to develop the system of NTA for Malaysia, which measures economic flows across age groups, for each of the member countries. The NTA provides a comprehensive framework for estimating consumption, production, and resource reallocations by age. With the NTA system, we will be able to gain important new information relevant to the following issues - Intergenerational Equity and Poverty, Aging Policy, the First Demographic Dividend and the Second Demographic Dividend.

Social Protection Indicator The purpose of this project is to develop a Social Protection Indicator for ASEAN countries. Such an indicator would assist countries to monitor and assess the development and adequacy of the three major types of social protection programs – social insurance, social assistance and labor market programs in their respective countries. The comparability of this indicator will also allow crosscountry comparison of social protection system performance.

Labor Force and Wages Study

The objective of this study is to examine wage differences by age, gender, employment sector and region. The proposed analysis will also estimate how wages by these characteristics have changed over time in response to government policies and economic conditions. This will also help us understand the issues of inequality and poverty.

Course (Masters in
Economics)

This course examines issues related to social policy, economic risks mitigation and social protection schemes; economics of social security; trends in social security reforms; role of social security in times of economic and financial crisis; choice of an appropriate social protection system and issues of sustainability, access, coverage and intergeneration equity; challenges to developing economies; and Malaysia's social security schemes and legislative codes.

Personal Financial Management This seminar aims to promote and educate participants to plan and manage their finances for future retirement. It intends to equip the participants with basic and essential financial knowledge. Conducted at least twice a year, it is held in collaboration with trainers or speakers from various institutions such as Employees Provident Fund (EPF), Private Pension Administrators (PPA), Federation of Malaysian Consumers Associations, Credit Counseling and Debt Management Agency (AKPK).


