Message from Director

I am honoured to present the Social Wellbeing Research Centre (SWRC) In Review 2017-2019, which provides key highlights and important milestones for the Centre during the past three years.

As the Director of SWRC, I envision our centre as part of an integral platform to advance social wellbeing research and development that transcends the boundaries of academia, providing and enabling vast societal impact to attain social inclusion and cohesion. The unique mix of academic and corporate culture at SWRC, shaped by our strong commitment to the stakeholders, enables us to report a significant progress in our performance, the results and future plans of which I am privileged to share in this In Review.

SWRC is a distinctive multidisciplinary research centre focused on conducting, supporting, and strengthening knowledge and education in social protection and wellbeing. With each step we take, a relationship is forged – with our fund contributor, colleagues, partners, communities, and the policy makers. These relationships are important to us because it is through the work with each of our stakeholder that SWRC has been impactful.

The world is now transforming in many ways compared to what it was a decade ago. The Industry Revolution 4.0 (IR 4.0) and the emergence of Artificial Intelligence (A.I) pose a huge impact on the labour market. IR 4.0 brings forth the gig economy which many Malaysians have begun to opt in, and this begs a question on how they can save for their old age and retirement, since informal workers are not covered by the Employees Provident Fund (EPF) and the Social Security Organisation (SOCSO). The A.I revolution has also displaced many full-time workers, attracting them to gig economy to make ends meet.

SWRC prides itself at being one of the policy initiators in the establishment of the Malaysia Social Protection Council (MySPC), approved by Cabinet in a meeting held in 2016. SWRC has been instrumental in the development of the National Social Wellbeing Blueprint, one of MySPC's initiatives.

The period 2017-2019 saw many firsts in Social Protection, initiated by SWRC for the nation. In 2019, SWRC launched an expenditure guide for the Malaysian households, aptly termed Belanjawanku, the first of its kind in South East Asia.

SWRC has also successfully completed the first wave of the Malaysia Ageing and Retirement Survey (MARS) in 2019 and a snapshot has been produced to highlight the outcomes of the survey. Providing a longitudinal micro database, the study is very timely for policy purposes as it gives a continual update on the actual scenario on ageing in the country. Following the success of the first wave, the second wave of MARS will be implemented in the middle of 2020.

SWRC entered the new decade by revisiting our strategic direction, with close facilitation and guidance from EPF. Aimed at steering SWRC to be more focused, strategic and agile, amidst a world that is full of challenges, uncertainties and volatility, as to be able to play our role effectively.


2020 will go down in history as a year of crisis of monumental proportions, with the COVID-19 Pandemic upending lives and livelihoods globally. Nevertheless, the crisis has underscored the vital role of social protection in the development of policies.

It is our hope that the National Social Wellbeing Blueprint and a National Social Protection Act that subsumes the dimensions of social protection become a reality in due course. Both the Blueprint and Act aim to consolidate existing fragmented social protection arrangements into a coherent, effective and impactful social protection ecosystem, based on the life-cycle approach covering three main components; Social Assistance, Social Insurance and Labour Market policies. The overarching principle is to move away from social welfare approach of a charity model to a progressive one. Comprehensive Social Protection is fundamental to reducing and preventing poverty throughout the life cycle.

There certainly are so much to do for SWRC, and so many challenges to navigate. We thank our stakeholders for constantly reminding us to learn, unlearn and relearn in order to stay current and be ahead. Stewardship, engagements and advocacy are what we will continue to do. All these with one thing in mind, inclusive Social Protection, to ensure that no one is left behind.


About SWRC

Since its inception in March 2011 at the Faculty of Economics and Administration (FEA), Universiti Malaya, SWRC has been providing evidence-based expertise and consulting in the aforesaid domains to elevate economic development and social cohesion in Malaysia.

Both developed and developing nations are concerned about social security and old-age financial protection due to the increase in the life expectancy of the population in tandem with decreasing fertility rates. These nations are concerned that their current social security provisions are inadequate and / or may not be sustainable. On the public finance side, merely incurring further expenditure may not solve the issues that challenged the development and growth objectives of the society. Malaysia Ageing & Retirement Survey (MARS)

MARS is a major research undertaking by SWRC to produce nationwide longitudinal micro-level data relating to ageing and retirement involving personal interviews of individuals aged 40 years and older in Malaysia.

ARS collects information on vital issues impacting their lives which include personal, family, health, economic and other social factors. MARS data are to be harmonised with leading international research data so as to enable adoption of best practices and comparability of findings across participating countries around the world. It is hoped that the rich potential of MARS data from such a longitudinal study will become a pivotal source of invaluable inputs in promoting research and development opportunities, and enhancing policy making for active and healthy ageing in Malaysia.

The main objective of MARS is to produce comprehensive micro-level data on various aspects of ageing and retirement impacting the lives of mid-aged and older persons which will provide useful input for policy making and the formulation of National Framework for Active and Healthy Ageing Malaysia towards strengthening social protection system for the country.

Specific objectives of MARS

- To produce a comprehensive base-line data on the individual, family, social, economic and health of middle-aged and older persons;
- To collect longitudinal data on life histories and experiences of middle-aged and older persons over time so as to gain a deeper understanding of the issues and challenges related to retirement and ageing;
- To offer evidence-based recommendations on opportunities and policies to address the trends that emerge in the midst of population ageing in Malaysia;
- To be part of the global platform on retirement and ageing research comparable with similar longitudinal surveys that can provide the basis for policy making and academic studies.



MARS will be a national landmark in scientific research that will provide a much needed foundation for a better understanding of ageing related issues in Malaysia and designing appropriate evidence-based policies for adults and older people.

MARS is adapted from the Health and Retirement Study (HRS) in the United States through collaboration between SWRC and the Survey Research Center (SRC), University of Michigan. SRC provides support in the development of MARS study design, training and technical assistance prior to, during and post-production of MARS data to ensure quality data as validated through regular monitoring of the fieldwork and random call 36 backs.

MoU Signing with University of Michigan

n 7 March 2018, University of Malaya representing SWRC and the Regents of the University of Michigan officially signed a Memorandum of Understanding (MoU). n order to prepare MARS for large scale data collection for longitudinal study and the usage of computer-assisted interviewing MARS team members were invited to attend the Health and Retirement Study (HRS) interviewer training on 7 - 14 April, 2018 in Detroit, Michigan and computer personnel technical training in Ann Arbor, Michigan, from 16 - 20 April, 2018.





Field Interviewers Training

ue to the complexity of the system used for MARS, all MARS Field Interviewers are required to complete a 4-day training at SWRC. The training were conducted by experts from University of Michigan, U.S. as well as local experts. All Field Interviewers were evaluated based on performance during training and group exercise as well as individual certification session.

The training covered background of the study, general interviewing technique, computer software training and more. From the period of 2018 to 2019, a total of five training sessions were conducted and attended by over 150 Field Interviewers from all over Malaysia.







Data Collection





August 2018 to May 2019 covering all states in Malaysia, including Sabah and Sarawak. Overall, 9,543 households were visited. The average duration per individual interview is 68.3 minutes, where at least 391 questions on average were asked.

MARS Townhall Meeting for Preliminary Findings

WRC had organised the MARS Town Hall Meeting on 20 September 2019 at Hotel Armada, Petaling Jaya. The objective of the meeting was to share the preliminary findings from MARS with various government ministries such as Ministry of Health, Ministry of Economic Affairs, Department of Statistics, Ministry of Women, Family and Community Development, etc., Securities Commission, EPF, Pension Retirement Schemes (PRS), Retirement Fund Incorporated (KWAP), Financial Planning Association of Malaysia (FPAM), local community and enumerators. It was a fruitful discussion and with a lot of ideas and inputs for improvements, especially from the members of the public.

Reference Budget for Malaysian (Belanjawanku)

SWRC has started a research programme aimed at compiling a "Reference Budget for Malaysian", or aptly named Belanjawanku. A reference budget is a basket, or collection of goods and services that are required in order to attain an acceptable standard of living. Belanjawanku provides detailed estimates of minimum monthly expenses on different baskets of goods and services consumed by different households. It is based on actual spending patterns of individuals and families from urban households in the Klang Valley and selected cities in Malaysia which act as a guide for household monthly expenses and personal budgeting.



The underlying motivation for developing Belanjawanku was the problem of low financial literacy, over-indebtedness among Malaysians and the rising cost of living.

To come up with Belanjawanku, SWRC has put together common expenditures on food, housing, utilities, transport, childcare, personal care, and many more.



To estimate how much each type of household needs to spend on these items, SWRC conducted a study of household expenditures, and survey of prices of goods and services through catalogues, the internet, and at actual business premises, between July 2017 and July 2018.

Subsequently, Focus Group Discussions with academicians, representatives from the EPF, Credit Counselling and Debt Management Agency (AKPK), Economic Planning Unit (EPU), National Wages Consultation Council (MPGN), Central Bank of Malaysia (BNM), as well as NGOs, industry specialists, experts from financial institutions, and reference persons from different households. The findings from the surveys and discussions were used to construct the "Belanjawanku Guide for Individual and Family Expenses". Belanjawanku provides an alternative reference to the official Poverty Line Income (PLI) as well as the living wage, and is more in tune with the standard of living that Malaysians aspire to.

On 4 th March 2019, Malaysia's Finance Minister Lim Guan Eng launched Belanjawanku, Malaysia's Reference Budget for individuals and families living in the Klang Valley. Speaking during the launch, the Minister expressed the government's support for Belanjawanku's development as it is in line with government's effort to raise the level of financial literacy among Malaysians. Also present at the event organised and hosted by Employees Provident Fund (EPF), were the Fund's chairman Tan Sri Samsudin and CEO Tunku Alizakri Raja Muhammad Alias, as well as Universiti Malaya Vice-Chancellor Datuk Ir. (Dr) Abdul Rahim Hashim and SWRC Director Emeritus Professor Datuk Norma Mansor. Malaysia is the first 45 country in Southeast Asia to have produced its own Reference Budget.







The Social Security Organisation (SOCSO) has implemented a programme called Return-to-Work (RTW) since 2007 whereby every injured worker is assigned a case manager who will facilitate intervention using a biopsychosocial and multidisciplinary approach. Many disability and vocational rehabilitation programmes have been introduced to help restore injured workers to their former productive life.

To provide quality services to its members, SOCSO's case managers and employees dealing with RTW programme-related matters, including work placement officers and those working in SOCSO Rehabilitation Centre are required to have professional certification in disability management practice.



In 2017, SOCSO appointed SWRC as the Test Agency to manage and administer the Certified Disability Management Professional (CDMP) and Certified Return-to-Work (CRTWC) Programme examinations. These two professional certifications are globally administered by the International Disability Management Standards Council (IDMSC) through its secretariat, the National Institute of Disability Management and Research (NIDMAR).

The CDMP and CRTWC designations are also referenced in the global Return to Work Best Practice guidelines developed, validated and published by the International Social Security Association (ISSA), a UN affiliated agency located in Geneva.

SWRC has been working closely with SOCSO in adapting and updating the NIDMAR training programme consisting of 25 modules according to the Malaysian context. The 25 modules were developed based on the Occupational Standards nine domain areas identified as core skills and competencies for effective Disability Management practice. In 2019, CDMP and CRTWC examinations were opened to all. Intensive training will be provided prior to the examination. Eligibility qualifications for the CDMP and CRTWC include at least a diploma in health-related fields. Such initiative made Malaysia the only country in ASEAN to offer such training and one of the two in Asia, of which the other is Hong Kong. The aim is to open this programme to countries in the region.

Certified International Pension and Retirement Professional (CIPRP)

The Certified International Pension and Retirement Professional (CIPRP) is an initiative implemented by SWRC, University of Malaya, the Employees Provident Fund (EPF) in collaboration with the International Training Centre of the International Labour Organization (ITC-ILO), Turin, Italy. CIPRP modules cover the fundamentals of social protection, retirement science, and personal financial planning delivered in a highly interactive learning environment.



The objectives of CIPRP are to:

- To expose the participants to the dynamics of retirement and social protection.
- To equip participants with knowledge and skills in retirement science.
- To enhance personal development of pension and retirement professionals

Through the partnership between SWRC, EPF and ITC-ILO, participants will have both the local and international flavours in terms of learning and sharing of experience from the academia, industry and international experts. CIPRP is a residential program conducted at EPF Learning Campus which provides state of-the-art facilities. It is a 3 days 2 nights full board package with residential and recreational facilities.

The CIPRP is designed for executives in the finance and insurance industry, retirement planning and advisory services as well as professionals from all other sectors who wish to deepen their knowledge and skills in social protection, pension system and long-term care.

This professional certificate provides the opportunity for participants to be equipped with knowledge and skills in four main modules namely:

1. Introduction to Social Protection

Participants will be introduced to the concept of social protection which includes social insurance, social safety net and employment related policies. The topic covers retirement, healthcare, international social security law, and solidarity and collective responsibility of society to provide economic security to its members. The discussion also includes social protection system throughout the life cycle with case studies from selected countries.

2. Financial Planning Process

Participants will be exposed to the steps in formulating financial planning strategies. The financial planning process includes analyzing individual's current financial situation with regards to income, savings, living expenses, assets and debts. Candidates will be guided in developing individual's financial goals and expectations, identifying and evaluating courses of action, creating, implementing and monitoring the financial action plans.

3. The Principles of Investment

This session covers concepts of investment, personal investment portfolio management including the management of investment in stocks, bonds, and other financial instruments. The session also includes guidelines on investment planning and emphasizes on how return from investments can be optimized by the use of investment strategies adaptable to changing economic conditions.

4. Old Age Protection & Health Planning

This session talks about social science dealing with health and care for older persons. It includes universal health coverage, health insurance and geriatric models. The issues on health coverage for the older persons, long-term care, existing frameworks and the effective management of these facilities will also be included.

Inaugural CIPRP

The inaugural CIPRP program was held from 5th August 2019 to 7th August 2019 at EPF Learning Campus (ELC), Bangi. The programme was launched by Emeritus Professor Datuk Dr. Norma Mansor and Puan Balqais Yusoff. A total of 23 participants attended the 3-day programme. The participants were from various private and government department, ministries and agencies.

Social Protection for Postgraduates (EXGA 6314, MEc)

Training Workshop on Costing Social Protection Measures for Malaysia

This 2-day workshop aims at building national capacity on costing a country-specific set of interventions that will ultimately consolidate an effective first layer economic security Social Protection Floor. The training is particularly important to ensure national ownership and transfer of skills so next generation of costing can be in-house (with only limited peer reviewing for consistency and validation). This country-specific and hands-on interactive workshop focuses on ways to build a consistent model and how it can be replicated with new selection of parameters (benefit, age, eligibility, benefit amount, and indexation).



AMJAD RABI is a social security economist with experience across many countries at different development stages. More recently, he has worked as an advisor for Malaysia's Employees Provident Fund (EPF) as well as for Oman's

Public Authority for Social Insurance (PASI). Amjad earlier served in senior positions in the United Nations' country offices in Malaysia, Nepal, Zimbabwe, Egypt, and Argentina and UN offices in New York and Geneva. Amjad has taught both graduate and undergraduate courses at Nottingham University, Malaysia campus, Balsillie School of International Affairs, Canada, and Lazaridis School of Business and Economics, Canada.

MARIO ARTURO RUIZ ESTRADA is SWRC's Senior Research Fellow. The objective of this workshop is to explore about the past, present, and future of policy modelling from both qualitative and quantitative perspectives. Over the

years the focus of the policy modelling literature has changed. The changes encompassed research topics, approaches, techniques, theories, methods, and analytical tools that are required for the rigorous analysis of complex and dynamic economic phenomena in policy modelling. At the same time, this workshop aims to introduce a method of classifying and evaluating policy modelling. An analytical tool called "Policy Modelling Consistency (PMC-Index)" has been developed for the purpose of evaluating policy modelling. PMC-Index enables policymakers and researchers to identify the level of consistency as well as the strengths and weaknesses within any policy modelling. This workshop promotes multidisciplinary approach to policy modelling and suggests that various possible effects of any economic policy can be shown using a multi-dimensional modelling approach.

Book Launch "Who Says I Am Retired?" & Panel Discussion on "Happy Ageing? You Decide"





On 15 January 2019, SWRC launched a book entitled "Who says I am retired?" – a compilation of miniautobiographies featuring senior civil servants, corporate leaders and academicians who have come together to redefine society's traditional idea of retirement. It is a mix of 33 essays and articles to share their ideas of what work means to them and their motivation to remain actively engaged in work and society in their golden years.



The authors of the articles comprise mainly of academicians, and professionals from the corporate sector and the civil service. Most of the authors were over 70 years old and the focus of these essays is on activities that they do after retirement, including their current work, engagement in civil societies, helping others, learning new skills, travelling and social interaction. The book launch was followed by a hearty and fruitful panel discussion on "Happy Ageing? You Decide", where five of the renown veterans featured in the book, including Tan Sri Datuk Dr Rafiah Sali, Tan Sri Dato' Dr Ramon Navaratnam, Tan Sri Sheriff Mohd Kassim and Professor Sulochana Nair, spoke of their lifelong work experiences.

Through this book project, which was initiated in 2015, the SWRC has found that Malaysia is similarly undergoing an evolution in career perception as there is an active community of people who have reached the legislated retirement age, but continue to be productively engaged or contributing to the community. Among retirees who have adequate savings or defined-benefit pension, there are those who continue to participate actively in civil society activities and picking up new skills.



Third International Conference on Social Protection

SWRC organised its Third International Conference on Social Protection on 10-11 October 2017 at Hilton Petaling Jaya. The theme was on "Migration, Development and Social Welfare: Implications and New Insights". The objectives of the conference were to explore the contemporary trends and patterns of global migration on cities and regions; highlight the consequences of international migration in its different forms on the host and home economies; identify the social and cultural dimensions of migration including policies and practices related to assimilation, integration and other factors, and assess traditional and innovative welfare policy responses to guide future policies on migration. This edition of international conference on social protection was held in collaboration with UNICEF.

The conference was divided into 6 separate platform sessions throughout the duration of the 2-day event. The session platforms were Retirement Migration, rural Urban Migration, Labour Market and Irregular/ Illegal Migration, Demographic Changes and Social Well-being, Education, Health and Social Protection and Economics and Social Policy. A total of 77 participants attended the 2-day conference. There were a total 16 presenters for 17 papers, 3 keynote speakers and 1 Public Lecture.

The first international conference was held in July, 2012 with "Population Ageing: Issues and Challenges" as the theme, held in collaboration with the National Population and Family Development Board (NPFDB), Ministry of Women, Family and Community Development Malaysia.



SWRC also organised the Second International entitled "Social Dimensions of Economic Development and Productivity: Lessons, Challenges and Opportunities for South East Asia" in December, 2014. It was organised in collaboration with the Department of Development Studies of the Faculty of Economics and Administration, and the Institutions and Economies Journal.

the Floor? **Economic** Lifting **Development Social Protection &** the Developing World's Poorest

Date: 30 January 2019

Standard measures of poverty may reveal nothing about whether the poorest of the poor are being lifted-up or left-behind, yet this is a widespread concern among policy makers and citizens. The seminar discussed whether public spending on social protection benefits the poorest and hence lifts the floor, and what role economic development plays. Across developing countries, a higher mean income comes with a higher floor. The bulk of this income effect is direct rather than via higher spending on social protection. It is theoretically ambiguous whether people in richer countries have a higher floor to their living standards. Nor is it clear whether social protection spending reaches the poorest and thus lifts the floor. Social insurance (mainly public pensions) does the "heavy lifting" of the floor. Social assistance (mainly targeted cash-transfers) lifts the floor by only 1.5 cents per day on average, which is less than 10% of mean spending on social assistance. This was a joint seminar between Ungku Aziz Centre for Development Studies and SWRC.

Household Expenditure on Medical Care & Health in Australia

Date: 15 May 2018

Unlike the UK and many other OECD countries with national health service, the national health services in Australia are a blend of public and private sectors. Australians pay 1.5% of their taxable income as Medicare levy which entitles them free treatment in public hospitals, however, patients have no choice as to the doctor who would treat them. There is a waiting period for non-emergency treatments such as elective surgery. To avoid waiting and to be treated by a doctor of their choice, people opt for private health insurance. Most prescribed medicines are subsidised but still require co-payments. Therefore, medical care and health incurs out-of-pockets (OOP) expenditure for most households in Australia. It is estimated that OOP expenses account for almost a guarter of the national budget for health care in Australia. Presented at the seminar was an analysis of the OOP expenditure on medical care and health reported by a nationally representative sample of 10,046 households from the Household Expenditure Survey 2015.

The Speaker



MARTIN RAVALLION is currently the holder of Professor Roval Unaku Aziz Chair. He also holds the inaugural Edmond D. Villani Chair of Economics at Georgetown University. Prior to joining Georgetown University, he was the

Director of World Bank's research department. Martin has advised numerous governments and international agencies on poverty and policies for fighting it. He has written extensively on poverty and other economics subjects, including six books and over 250 papers in scholarly journals. In 2012 he was awarded the John Kenneth Galbraith Prize from the American Agricultural and Applied Economics Association, and in 2016 he received a Frontiers of Knowledge Award from Spain's BBVA Foundation. Martin is an Australian citizen who studied at the University of Sydney and the London School of Economics, where he obtained a PhD in Economics.

YUSUF FARHAT is Emeritus Professor of Demography at Macquarie University and Honorary Professor of Public Health at the University of Sydney. He is currently working on analysis of the National Health Survey data with

particular reference to the prevalence of mental and disorders, diabetes, smoking, alcohol consumption. Yusof is also leading a study on the incidence of hysterectomy, endometrial ablation and sterilisation in New South Wales. This study is based on hospital data pertaining to these procedures performed in public and private hospital in NSW during 2010-2012. Collaborators: Stephen Leeder and Andrew Wilson. His other research interests include health economics, in particular the out-of-pocket expenditure on healthcare, and the demography of ethnic minorities. His recent publications include two books – Methods of Demographic Analysis and Consumer Demographics both published by Springer. He has also written extensively on various population and health related issues. He is currently an Associate 82Editor of the International Journal of Epidemiology.

An Outline & Characteristics of The Japanese Study of Aging & Retirement (JSTAR)

Date: 7 September 2017


Despite the rapid aging of the Japanese population, no statistical survey that could properly capture the diversity of the elderly population from various viewpoints had been carried out in Japan until recently. Against this backdrop, RIETI and Hitotsubashi University jointly launched a comprehensive survey of elderly people in 2007 to collect panel data on their lives and health, with the University of Tokyo joining from 2009 onward. The data collected in this survey include diverse information on the economic, social, and health conditions of elderly people. In addition, the survey is designed to ensure, to the maximum extent possible, comparability with preceding surveys such as the Health and Retirement Study (HRS) in the United States, the Survey of Health, Aging and Retirement in Europe (SHARE) in continental Europe, and the English Longitudinal Study of Aging (ELSA) in the United Kingdom. By analysing JSTAR data, researchers can track the characteristics of the Japanese elderly population in terms of both their specificity and universality in the world.

Working Longer in an Aging Society: Employer Concerns and Worker Preferences

Date: 25 May 2017

Life expectancy at older ages is increasing. In order to achieve the same standard of living in retirement, individuals must either save more and consume less while working or retire at later ages. Working until later ages is an efficient method of maintaining retirement income as life expectancy increases. Governments also are likely to support delayed retirement as individuals continue to contribute to national output, pay taxes, and do not require retirement subsidies from national programs. It seems clear that governments and individuals seek to extend working life but how will employers react? The seminar focused on employer concerns if workers stay on the job past traditional retirement ages including the effect of more older workers on labour costs and productivity.

The Speaker



HIDEHIKO ICHIMURA,

is professor of economics at the University of Tokyo since 2005. He received his BA in Economics from Osaka University and his PhD from the Massachusetts Institute of Technology, United States.

He is the project leader of the ongoing study "Towards a Comprehensive Resolution of the Social Security Problem: A new economics of aging" at the Research Institute of Economy, Trade and Industry (RIETI) which collects the panel data: Japanese Study of Aging and Retirement (JSTAR). He has contributed a number of influential articles in journals such as the Journal of Econometrics. His research area focuses on the development of program evaluation methods as well as the examination of conditions under which various estimation problems are considered in econometrics.

program on Aging. He is a member of Pension Research Council at the Wharton School, University of Pennsylvania and is a Fellow of the Employee Benefit Research Institute and the TIAA-CREF Institute. Professor Clark has conducted research on retirement decisions, defined benefit, contributions plans, the impact of pension conversions and government regulation on pensions. In addition, he has also examined the role of supplementary retirement saving plans in the public sector, employer-provided financial literacy programs and how workplace events affect retirement decisions. His other long standing interest includes the evolution of retirement systems in Japan and how population aging has affected the Japanese economy.

Based on the National Transfer Accounts (NTA) indices for Japan, this discussion focused on changing patterns of the three components of age allocations, namely; public transfers, private transfers, and assets from 1984 to 2009, with particular emphasis on the economic status of the elderly. Additionally, analysis shows how useful the Japanese elderly can be in inducing effective policy responses intended for the alleviation of the burden of Japan's unprecdented population ageing. As a partial solution for economic issues brought about by Japan's rapid population ageing, the importance of financial education among the elderly is emphasised.


